


REDWOOD PARKWAY-FAIRGROUNDS DRIVE IMPROVEMENT PROJECT

NOTICE OF AVAILABILITY OF DRAFT ENVIRONMENTAL IMPACT REPORT/ ENVIRONMENTAL ASSESSMENT (EIR/EA) AND PUBLIC MEETING

WHAT'S BEING PLANNED: The Solano Transportation Authority (STA), Solano County, and the City of Vallejo, in cooperation with the California Department of Transportation (Caltrans), propose to modify the existing Interstate 80 (I-80)/Redwood Parkway interchange, realign the Fairgrounds Drive/Redwood Street intersection, widen Fairgrounds Drive between Redwood Street and State Route (SR 37), widen the westbound exit ramp from SR 37 to Fairgrounds Drive, and improve several local intersections.

WHY THIS NOTICE: A draft environmental impact report/environmental assessment (EIR/EA) has been prepared for the Redwood Parkway-Fairgrounds Drive Improvement Project (project). This notice is to inform you of the availability of the EIR/EA for public review, and that a public meeting will be held to provide you an opportunity to comment on the environmental document before the final design alternative is selected.

Additionally, noise abatement options have been evaluated at potential noise affected areas along the project corridor. The location of the noise measurements and abatement options will be presented at the public meeting and comments regarding the potential barrier locations are requested.
