Solano Comprehensive Transportation Plan Update in Progress

SUISUN CITY, CA - The Solano Transportation Authority's Comprehensive Transportation Plan (CTP) is being updated with input from our member agencies (all seven Cities and the County) and the community. The plan update (called "Solano 2040") identifies and prioritizes the transportation needs and funding throughout Solano County for the next 25 years.


STA is visiting locations throughout Solano County seeking input on the plan. STA has developed an online survey tool for Solano 2040 where the public can indicate what their transportation priorities are, and provide their own idea about how to improve transportation in Solano County. Visit www.solano2040.org to give your input into this planning process.

Solano 2040 covers policies, programs, and projects for transportation in the seven cities (Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville, Vallejo) and unincorporated Solano County. The plan also covers inter-regional connections to neighboring counties and the northern California region. The current CTP 2030 was finalized in 2005, which incorporated the following three elements: Active Transportation (approved in 2014); Arterials, Highways and Freeways; and Transit and Rideshare ([see here for additional information](#)).

Programs and projects for the county and the seven cities must be listed in the STA Solano 2040 in order to be eligible for regional, state or federal transportation funds and to be included in the Metropolitan Transportation Commission's (MTC) Regional Transportation Plan (RTP), called [Plan Bay Area](#). STA distributes those funds based on the Solano CTP and Plan Bay Area. It is important that every resident of Solano County has the opportunity to have their voice heard in shaping Solano County's transportation priorities.
