

Solano Transportation Authority 2014 Year in Review January 14, 2015 STA Board Meeting

FEBRUARY

- Anthony Intintoli appointed for second term by Governor to the WETA Board
- Caltrans activated the first of many ramp meters in Solano County in Fairfield segment of I-80
- County of Solano started collecting an updated County Facility Fee with STA administering a
 portion of the fee as a Regional Transportation Impact Fee to help fund transportation
 infrastructure

MARCH

- Entered into a funding agreement for the City of Fairfield to provide a \$10.4M local match for the I-80/I-680/SR 12 interchange
- Approved \$9.3M in STIP funds for the Fairfield/Vacaville Intermodal Station
- STA Board Members traveled to Sacramento to discuss STA's state transportation priorities with legislators and agency staff

APRIL

- STA Board Members traveled to Washington DC to discuss priority projects and upcoming federal grant opportunities for Solano County
- Approved Active Transportation Element of the Solano County Comprehensive Transportation Plan
- Approved Solano County Mobility Management Plan

MAY

- STA's Solano Napa Commuter Information (SNCI) program coordinated the 20th annual Bike to Work Week campaign for Napa and Solano Counties with 667 participants at 9 Napa energizer stations and 17 Solano energizer stations
- Approved allocation of \$563,000 in TDA funds to Solano County for the Intercity Taxi Scrip, transit coordination, Faith in Action volunteer driver program, Intercity Paratransit Services
- Approved allocation of \$250,000 in TDA Article 3 funds to Dixon for the West B Street Bicycle and Pedestrian Undercrossing project
- Approved the updated Jepson Parkway Concept Plan
- Approved \$1.26M in Prop 1B funds for the Fairfield/Vacaville Intermodal Station, and a funding agreement between the cities of Fairfield and Vacaville for these project funds
- I-80 EB Truck Scales Facility won the California Transportation Foundation Safety Project of the Year
- CTC approved \$11M funding for Fairfield/Vacaville Intermodal Station
- Celebrated with WETA the Ferry Maintenance Facility Groundbreaking on Mare Island in Vallejo

JUNE

- Celebrated with Caltrans the Groundbreaking for the first of 7 construction packages for I-80/I-680/SR 12 Interchange project
- Celebrated with SolTrans the groundbreaking of the Curtola Park & Ride Hub Project in Vallejo
- Entered into a funding agreement with SolTrans to implement Public Private partnership for the Curtola Park & Ride Hub Project in Vallejo
- Adopted STA's first Title VI Program
- Authorized transfer of management of Intercity Paratransit Service and Taxi Scrip Program to STA from Solano County

JULY

- Approved Two-Year STA Overall Work Plan for FY 2014-15 and 2015-16.
- Entered into \$600,000 funding agreement with Rio Vista to initiate environmental phase of SR 12/Church Road Intersection Improvement project
- STA's Solano Napa Commuter Information (SNCI) Program formed 27 new vanpools in FY 2013-14

AUGUST

- Celebrated with the City of Dixon the grand opening of the West B Street Pedestrian and Bicycle Undercrossing Project
- CTC approved STA's competitive grant application for a \$389,000 Active Transportation Program Grant for Solano Safe Routes to School Program
- Countywide In-Person ADA Eligibility Program completed its first year of operation with 1,172 ADA evaluations in FY 2013-14 with an 86% "highly satisfied" response

SEPTEMBER

- Celebrated with Caltrans and Napa County Transportation and Planning Agency the grand opening of the \$126M SR 12 Jameson Canyon Widening Project
- STA's Abandoned Vehicle Abatement (AVA) Program abated 4,035 vehicles in FY 2013-14
- Approved allocation of \$37M of RM2 funds from MTC to the City of Fairfield for the Fairfield/Vacaville Intermodal Station and track improvements
- Allocated \$90,000 in TDA Article 3 funds for Dixon West B Street Undercrossing Project and \$10,000 for automated bike and pedestrian counters
- I-80 EB Truck Scales Project won Intelligent Transportation Society of America (ITS America) 2014 Best of ITS Awards in the category of best new innovative product, service or application

OCTOBER

- Approved STA's first Annual Pothole Report
- STA Board Members participated in Solano SR2S International Walk to School Day in all 7 cities, with a record 41 schools participating
- Celebrated with the City of Rio Vista the groundbreaking of the Waterfront Promenade Phase II Project
- Governor signed STA-sponsored legislation (SB 1368, Wolk) authorizing transfer of real property from Caltrans to SolTrans for the Curtola Park & Ride Hub Project in Vallejo
- Collection of RTIF fees through the 1st quarter of FY 2014-15 passed half million dollar mark

NOVEMBER

- Hosted 17th Annual STA Awards Ceremony at the CSU Maritime Academy in Vallejo
- STA's SNCI program conducted the 8th annual "Solano Commute Challenge" outreach campaign for Solano County employers, with 30 major employers totaling 660 employees participating countywide and 419 achieving Commute Champion status
- Opened the Transportation Info Depot at the historic Suisun City Train Depot and assisted 800 people in-person in the first 2 months of operation
- Completed right-of-way acquisition for Benicia Intermodal Project
- Clipper Card became available for use in Solano and Napa counties

DECEMBER

- STA's FY 2013-14 budget received an unqualified audit report (no findings) from an independent auditor for the ninth consecutive year.
- Adopted the STA 2015 Legislative Priorities and Platform
- Held STA Board Workshop on Intercity Transit Corridor Service Plan and selected service option B to be the focus of the Phase 2 Study.
