### To: Solano County Residents, the Business Community and our Partner Agencies and Representatives:

Transportation improvements in Solano County provide a better quality of life for our residents, improved movement of goods and services for local businesses, and create local jobs that help vitalize and build the local economy.

STA saw many successes in 2005. We initiated and completed several important transportation and transit project studies, and secured construction funds for much needed highway and arterial improvements.

The STA is dedicated to addressing Solano County's most urgent transportation needs by providing funding for highway and safety improvements, improving and expanding transit options, and for local projects such as road maintenance and bicycle projects.

Despite recent state and federal cutbacks in transportation funding, the STA has been able to ensure continued progress on our top priority projects, such as the I-80/I-680/SR  $\,$ 12 Interchange, the Jepson Parkway and State Route 12 projects. STA is working with the Metropolitan Transportation Commission (MTC) and our state and federal representatives to obtain the maximum amount of regional, state and federal funds for Solano County's transportation projects.

In 2005, through the MTC the STA allocated portions of Solano County's share of Regional Measure 2 funds, including funding for the I-80/I-680/SR 12 Interchange (\$100 million), the Vallejo Ferry Station (\$28 million), the Fairfield/Vacaville Train Station (\$25 million), Intermodal Transit Stations in Benicia, Fairfield, Vacaville and Vallejo (\$20 million), and expanded Baylink Ferry service and intercity express bus service on I-80 and I-680 in Solano County.

We look forward to a successful year ahead bringing transportation improvements to Solano County residents.

# STA's commitment

The Solano Transportation Authority (STA) was created under a Joint Powers Agreement in 1990 to serve as the Congestion Management Agency for Solano County. STA member agencies include the Cities of Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville and Vallejo, and the County of Solano. STA is responsible for countywide transportation planning and coordination, delivering priority projects, programming federal, state and regional transportation funds, and managing the Solano Napa Commuter Information (SNCI) program and two transit services.



# planning for the future

### Solano Comprehensive Transportation Plan

The Association of Bay Area Governments projects that Solano County will have the largest percentage of population and job growth of any county in the Bay Area during the next 25 years. Our population will grow from 422,000 in 2005 to an estimated 581,000 in 2030. While many new major employers are making the move to Solano County, a large number of Solano residents commute to jobs within Solano County and other counties—making the commute traffic on I-80, I-680, I-780 and State Route 12 an increasingly critical transportation problem. At the same time, Solano County has an increasing need for senior and disabled transit service, local roads maintenance and repair, and local intersection, bikeways and pedestrian safety projects.

The updated Solano Comprehensive Transportation Plan (CTP) identifies and highlights how Solano County plans to address its overall transportation needs for roads, highways and freeways, and will provide transit, bicycle, pedestrian, and transportation/land-use alternatives through 2030. The updated CTP was developed in partnership with STA's many transportation partners and the public.

### **TEA-21 Reauthorization (SAFETEA)**

The Transportation Equity Act for the 21st Century (TEA-21) was enacted in 1998 to ensure a strong and integrated national transportation and transit system, improve the environment and expand employment opportunities. The Business, Transportation and Housing Agency and the California Alliance for Jobs estimate that one job is created for every \$20,000 in transportation funding. The U.S. Department of Transportation selects projects for long-term funding based on a stringent set of criteria, including local financing. STA has been quite successful in getting state funds to match or supplement federal earmark funds, and local agencies have also committed significant local funds.

In August 2005, HR3, the Safe, Accountable, Flexible, Efficient Transportation

Equity Act: A Legacy for Users



(SAFETEA-LU) was signed into law to carry over the long-term reauthorization measure. The measure provides \$286.5 billion through FY 2008-09 for highway, mass transit and road safety programs, and ensures that California and other states receive at least 92 percent of the money they contribute to the Highway Trust Fund by 2008.

The bill provides earmarks of over \$34 million for key Solano County regional transportation projects, which is the largest amount of funds Solano County has received from a federal authorization bill. Solano ranked 16th out of 58 California counties in the amount of SAFETEA funds received. The projects receiving earmarks were:

- I-80/I-680/SR 12 Interchange (\$17.4 million)
- SR 12 Widening through Jameson Canyon (\$6.4 million)
- Jepson Parkway/Travis AFB Access Improvements (\$3.2 million)
- I-80 HOV Lanes/Interchange Construction in Vallejo (\$2.8 million)
- Cordelia Pedestrian/Bicycle Corridors Upgrade (\$2.4 million)
- Rio Vista Bridge Realignment Study and Street Sign Safety (\$560,000)

During 2005, STA developed priority projects for funding in 2006 (see



"Project Delivery," page 17 for more details). Over the next four years, Federal

SAFETEA-LU transportation bill will provide

new federal funds for Solano County projects.

### Solano Traffic Safety Study (Phase 2)

On July 13, 2005, the Solano Travel Safety Study, Phase I was adopted, which identifies travel safety deficiencies in Solano County and recommends a program of cost-effective travel safety programs and projects. The 2005 Travel Safety Plan identified 63 high accident-rate intersections countywide and measured the accident rates across all of Solano County's highways.

### **SR 12 Transit Corridor Study**

The State Route (SR) 12 Transit Corridor Study identified the need for future transit service along the SR 12 through Rio Vista, Suisun City, Fairfield and Napa. Spearheaded by a Policy Steering Committee consisting of representatives from Solano and Napa Counties, it analyzed potential travel demand and developed a preliminary bus schedule, route, stops and preliminary cost estimates. Once funding sources are identified and travel demand is sufficient, the SR 12 Steering Committee proposed to develop an implementation plan to initiate a phased transit service.

### I-80 Oakland to Auburn Regional Rail Study

This study evaluated options for operating passenger rail service on the existing Capitol Corridor line, connecting with Oakland, Emeryville and BART at its Richmond station and to Davis, Sacramento and Auburn. Led by a Policy Steering Committee including representatives from Solano, Contra Costa, Placer, Sacramento and Yolo Counties, this plan recommends three additional commuter trains traveling between Sacramento and Oakland, with departures every half hour during peak commute hours, when combined

with Capitol Corridor intercity service.

### project delivery

### I-80/I-680/SR 12 Interchange

The STA Board has identified the I-80/I-680/SR 12 Interchange as the highest priority transportation project in Solano County. Improvements to this critical link between the Bay Area and Sacramento will be even more urgent following the completion of the new Benicia-Martinez Bridge in 2007. The Project Approval/Environmental Documents (PA/ED) Phase of the project continues on schedule. The project will greatly improve automobile, bus and truck traffic flow, integrating High Occupancy Vehicle (HOV) lanes with additional travel lanes and a parallel local system roadway. The project has multiple phases to take advantage of funding, as it become available. Several independent transportation projects have been separated from the main interchange project (I-80 HOV Lanes and North Connector, see below) to provide more short-term relief.

The environmental impact studies for the full I-80/I-680/SR 12 Interchange project will be completed in 2009. STA, Caltrans and local agencies are analyzing various alternatives to maintain an acceptable level of service during construction. The full project is estimated to cost between \$885 million to \$1.2 billion.

### **New Benicia-Martinez Bridge**

Caltrans continues its work on the
new northbound span of the BeniciaMartinez Bridge, after developing a plan
to minimize impacts on fish traveling
though the Carquinez Strait. The STA
continues to work with MTC, Caltrans,
the Contra Costa Transportation Authority

 $\left( \text{CCTA}\right)$  and the City of Benicia to address local issues.

The new Benicia-Martinez Bridge will have five northbound lanes, four southbound lanes, a bicycle pedestrian lane, and capacity to add future light rail service. A new 17-booth toll plaza is being constructed in the

northbound direction on the Contra Costa side and a new interchange at I-680/I-780 has been constructed on the Solano County side. The project is funded by Regional Measures 1 and 2.

### **North Connector**

The North Connector project is a

parallel arterial road to I-80 which

will link the east and west sections of

State Route 12, providing local traffic an alternative to using I-80. The project is a five-mile arterial connection in Fairfield (including 1.4 miles of existing roadway) north of I-80 between SR 12 West and SR 12 East. The roadway will parallel I-80 between Abernathy Road and Suisun Valley Road, then connect with Business Center Drive and extend west to connect with SR 12 at the intersection of Red Top Road. The environmental report will be available for public comment in FY 2006–07 and construction of the first phase of this three-phase project is scheduled for completion in 2009. The total project is estimated to cost about \$90 million.

### Jepson Parkway

This innovative multi-modal corridor will increase mobility for residents within Solano County. The four-lane Parkway is a 12-mile alternative to I-80 for local traffic between the cities of Vacaville, Fairfield and Suisun City. It links the existing road segments of Leisure Town, Vanden and

The project has been divided into ten segments for funding and prioritizing. About \$80 million in local, state and federal funding has been secured. Two segments have been completed and two more

### State Route 37/29 Interchange

State Route 37 passes through the sensitive

and III were completed in 2005:
construction of a four-lane
freeway in each direction
from the Napa River Bridge
to Diablo Street in Vallejo, and
construction of a cloverleaf interchange at Highway 37/29. Caltrans
completed the project in September 2005 at

### Highway 12 – Jameson Canyon

STA and the Napa County Transportation

Planning Agency (NCTPA) have secured \$5.6 million in state funds to complete environmental and design work for realignment and safety enhancements on Highway 12 between I-80 in Solano County and Highway 29 in Napa County. The project is currently in the environmental phase with Caltrans as the lead agency. The project is estimated to cost approximately \$140 million. An additional \$6.4 million federal earmark was received by NCTPA in 2005 as part of SAFETEA-LU.

### Fairfield Transportation Center (Phase 3)

expected to commence by the end of 2006.

A second phase of the Fairfield Transportation Center was completed in late 2004, adding a total of 240 additional parking spaces for commuters. The center also has parking for commuters who use express buses, carpools and vanpools. A final phase improvement will consist of an additional parking structure with 600 spaces, and design is



The Vallejo Intermodal Station will be the primary ferry/transit terminal in the North Bay,

providing congestion-free transit to 15,000 daily riders. The Baylink Ferry is the most successful ferry service in the Bay Area—with three high-speed ferries in service—and is a vital link between San Francisco and Solano County. The new station will act as a catalyst for attracting private sector investment in Vallejo's downtown and along the waterfront. Surrounding land uses will transition to residential and "live work space," small retail offices, restaurants, open space and a renewed and dynamic downtown Vallejo waterfront.

The project will provide up to 1,800 off-street parking spaces, new local and regional bus transfer facilities, roadway access improvements, and new bicycle/pedestrian connections between downtown Vallejo, the intermodal station and the waterfront area. Regional express buses from this location

will serve Napa Valley, key BART stations, multiple stations along

I-80 to Fairfield, Vacaville, Davis and Sacramento.

STA and the city of Vallejo have secured \$54.26 million in funding including an earmark for \$850,000 in federal funds in 2005. The



project is estimated to cost \$65 million and construction is scheduled to begin in 2008-09.

### Fairfield/Vacaville Intermodal Train Station

and the City of Fairfield in 2005.

This transit-oriented development at the crossroads of Jepson Parkway and Peabody Road will provide automobile, bus, vanpool, bicycle and pedestrian access to Capitol Corridor Train Service. The station and related track improvements are key to meeting ridership requirements that will allow Capitol Corridor to expand service during 2006 from 12 to 16 intercity trains a day, plus additional peak hour commuter service by 2010-2015. Trains will serve Fairfield and Vacaville residents commuting to points along the Capitol Corridor as well as employees traveling to Travis Air Force Base and the major employment centers in Fairfield and Vacaville. \$29 million in local, regional, state and federal funds have been secured to construct the initial station and track improvements, including an additional \$500,000 in federal appropriations funds received by the STA

### **Solano Napa Commuter Information**

The Solano Napa Commuter Information (SNCI) program provides information about alternative transportation modes to Solano and Napa County residents and employees. The SNCI program is a partnership between the STA, the Napa County Transportation Planning Agency, MTC, the Bay Area Air Quality Management District and the Yolo Solano Air Quality Management District.

Solano County commuters have the longest average commutes in the Bay Area—and the highest percentage of car/vanpooling. SNCI staff work with employers to promote alternative transportation. SNCI provides incentives to encourage residents to choose methods other than single occupancy cars for their commute, work closely with transit operators to provide up-to-date local and regional bus, rail and ferry information and work with residents to create alternative transportation plans.

SNCI coordinates outreach campaigns such as The Great Race for Clean Air and California Bike to Work Day. SNCI program staff attends events such as farmer's markets, job fairs, business expos, and community festivals to provide services to Solano County and Napa County residents.







### STA financials

The Solano Transportation Authority (STA) is annually required to prepare financial statements in accordance with Government Accounting Standards Board Statement Number 34 (GASB 34). In addition, the STA is required to prescribe a uniform accounting policies and procedures in accordance with the Single Audit Act of 1984, and the Office of Management and Budget (OMB) Circular A-133 (Audits of States, Local Governments, and Non-Profit Organizations), and Circular A-87 (Cost Principles of State, Local, and Indian Tribal Government).

The STA Board adopts a two-year budget for the operations and programs of the STA. This rolling two-year budget is updated with adoption of the annual budget. This budget system provides and authorizes STA the basis for appropriate budgetary control of its financial operations for the fiscal year and for multi-year funded projects.







### **Technical Advisory Committee**
