PEDESTRIAN ADVISORY COMMITTEE (PAC) Minutes for the Meeting of June 1, 2017

1. CALL TO ORDER/SELF INTRODUCTIONS

The meeting of the STA's Pedestrian Advisory Committee (PAC) was called to order by Chair Kevin McNamara at approximately 6:08 p.m. at the STA in Conference Room 1.

2. CONFIRM QUORUM

Quorum is confirmed.

3. APPROVAL OF THE AGENDA

With a motion from Teresa Booth and a second from Sandra Newell, the PAC unanimously approved the Agenda (6 Ayes, 3 Absences, 0 Abstentions).

4. OPPORTUNITY FOR PUBLIC COMMENT

None.

5. COMMENTS FROM AGENCY STAFF

Anthony Adams announced that STA was just awarded two grants today from the Office of Traffic Safety (OTS). One grant primarily focuses on safe routes to middle and high schools. The other grant is to standardize data collection to assist with collision reporting throughout Solano County because currently only a few jurisdictions have a collision reporting system that has GPS. Mr. Adams stated that both grants are around \$170,000 each for a total of \$340,000.

6. CONSENT CALENDAR

Approve the following consent item in one motion. (Note: Item under consent calendar may be removed for separate discussion.)

 A. Minutes of the STA PAC Meeting of February 2, 2017 and April 6, 2017 On a motion by Sandra Newell, seconded by Joseph Joyce, the STA PAC approved the minutes of February 2, 2017 and April 6, 2017 unanimously. (6 Ayes, 3 Absences, 0 Abstentions)

7. PRESENTATIONS

A. Linear Park Corridor Study – Status Update

Bob Macaulay provided an overview on the Linear Park Corridor Study to evaluate improvements to the Linear Park Trail, between Dover Avenue and Pennsylvania Avenue. The Linear Park Trail has always had the potential to serve as a quality community gathering space and provide a pedestrian and bicycle corridor for school children, cyclists, and commuters. The study will develop design concepts to reactivate community spaces, improve non-motorized intermodal transit, and reduce blight and crime along the corridor. Mr. Macaulay stated that there is a community taskforce that is working to improve Linear Park and he will update PAC members with the next available dates to encourage members to attend future meetings. He asked PAC members what the Linear Park Trail is used for and why people don't use the trail. PAC members responded that the public doesn't feel comfortable using the Linear Park Trail because it feels unsafe, there's not enough lighting, the trail is not well maintained (glass all over the area), and homelessness.

B. Community Walkability Mini-Grants and Plans

Kirbee Brooks announced that there is funding available to offer 10-15 mini grants of \$1,000 to \$2,000 to community groups or to individuals to implement or assist in existing walkability efforts in the county. The Request for Proposals (RFP) has been approved by the grant advisor. The RFP should be released in the next two months. Ms. Brooks encouraged PAC members and STA staff to recommend community groups to apply for these grants. Kevin McNamara asked what the scope of these grants are, and which specific groups may apply. Ms. Brooks responded that it's very broad which specific groups we are looking for and that a group of applicants have already been selected to be evaluated, but there isn't specifically one characteristic they are looking for in the grant applicants. Anthony Adams addressed that Ms. Brooks mentioned community groups and STA has a Safe Routes to School (SR2S) Community Task Force. Mr. Adams was wondering if they may be eligible to apply for these mini grants and Ms. Brooks responded that the SR2S Community Task Force should be eligible for these grants. Ms. Brooks will provide more information on the grant in the near future and encourage any agencies or community groups to send recommendations to her.

C. One Bay Area Grant (OBAG) Cycle 2 Status

Anthony Adams presented an overview of the OBAG Cycle 2 Status. Mr. Adams discussed OBAG Cycle 2 Congestion Mitigation & Air Quality Program (CMAQ) funding recommendations and Tier 2 projects funding strategy. He also presented an overview of all the projects submitted for OBAG Cycle 2. Cynthia Ripley requested copies of the OBAG Cycle 2 Status PowerPoint be emailed out to all the PAC members to review.

8. ACTION FINANCIAL None.

9. ACTION NON-FINANCIAL

A. Elect PAC Chair and Vice – Chair for 2017

Recommendation:

1. Nominate and elect a PAC Chair for the remainder of 2017.

2. Nominate and elect a PAC Vice-Chair for the remainder of 2017.

On a motion by Pete Turner, seconded by Sandra Newell, the STA PAC nominated Kevin McNamara for PAC Chair and Teresa Booth for the PAC Vice – Chair for the remainder of 2017. (6 Ayes, 3 Absences, 0 Abstentions)

B. Elect PAC Representative for the Active Transportation Subcommittee

Bob Macaulay provided an overview on the Active Transportation Subcommittee. Mr. Macaulay stated that there will likely be two meetings for the remainder of this year and he noted that the meetings tend to occur during midday.

Recommendation:

Appoint a PAC Representative to serve on the Active Transportation Subcommittee. On a motion by Pete Turner, seconded by Kevin McNamara, the STA PAC appointed Sandra Newell to serve as a PAC Representative on the Active Transportation Subcommittee and Teresa Booth to serve as the alternate. (6 Ayes, 3 Absences, 0 Abstentions)

C. Active Transportation Plan – Purpose

Ryan Dodge provided an overview of the Active Transportation Plan. Mr. Dodge addressed the Countywide Bicycle Transportation Plan and the Countywide Pedestrian Transportation Plan was last updated in 2012 and each of these documents are in need of an update. He highlighted that STA received approval from the STA Board of Directors in February 2017 to release a Request for Proposals (RFP) to consulting firms. Mr. Dodge indicated that STA staff is presenting the purpose statement to the PAC, followed by the Bicycle Advisory Committee (BAC), the Technical Advisory Committee (TAC), and the STA Board. STA staff seeks consensus from all groups to focus the RFP and to guide the plan throughout the process.

Sandra Newell noted about the percentages concerning the general population who are confident enough to bike anywhere and the overall population who won't ride a bicycle under any situation on paragraph 5 of Attachment A. Ms. Newell indicated that people who work full-time positions have a time limitation to utilize walking or biking as a means to commute to work compare to people who are retired. Cynthia Ripley added that Solano County is lacking safe biking routes for people to commute to and from work.

Ms. Ripley clarified with Mr. Dodge that Attachment A is the introduction to the RFP, and she added that the style that is typed is a little bit "dry." She recommended providing examples of other cities who had struggled with promoting active transportation and how they came up with a solution.

Pete Turner requested the RFP to indicate an outcome. He asked, "what do we intend Solano County to become?" Mr. Turner wanted Solano County to lead the way in active transportation. He also opposed the phrase, "build it, and they will come." Instead show how they will come and that they have to utilize active transportation. Peter Turned added that STA has to have an affect-based approach, and having people wanting to walk or bike to work instead of driving alone.

Teresa Booth addressed the efficient and effective use of funding to promote active transportation as well as improving access for people of different income levels. Ms. Booth stated that efficiency, connectivity, health, and awareness of the community we are serving provided us with a better idea of how we can better improve the use of active transportation in those communities.

Victor Anes implied that driving a personal vehicle shows status over riding public transportation. Bob Macaulay added that people who walk, bike, or take public transportation to work because they have no other choice.

Pete Turner suggested that people are more encouraged to walk for aesthetic reasons. For example, people are more likely to walk along the waterfront and Victorian houses versus walking through a business park to work.

Kevin McNamara suggested wider sidewalks to encourage group walking as well as additional safety for pedestrians.

Kirbee Brooks asked when the RFP would be released and Ryan Dodge and Bob Macaulay responded that it would be released mid-late July.

Recommendation:

Review and approve the proposed purpose of the Solano Active Transportation Plan in Attachment A.

On a motion by Pete Turner, seconded by Teresa Booth, the STA PAC proposed to recommend the language be forwarded to the BAC, the Active Transportation Committee for consideration and the final version be brought back to the PAC for further review. (6 Ayes, 3 Absences, 0 Abstentions)

D. Pedestrian Priority Projects List – Update

Ryan Dodge provided an overview on the Pedestrian Priority Projects List – Update. Mr. Dodge explained about the difference between Tier I and Tier II projects. As different funding sources becomes available, project priorities changes along with cost estimates. Ryan Dodge explained about the status of the Tier I and Tier II projects.

Cynthia Ripley suggested to add an additional column titled "Status" to the STA Pedestrian Priority Projects List.

Ryan Dodge explained which projects that were not a priority anymore and that no additional funding is needed to complete the project. Mr. Dodge suggested that PAC

members not focus on the cost of the project since the cost estimates were not completely updated, but instead to focus on which project has more value to remain on the priority list.

For the August PAC meeting, Teresa Booth suggested Ryan Dodge to highlight the priorities from the Tier II projects that needs more definitive actions.

Recommendation:

Review, change, and approve the STA Pedestrian Priority Project List for FY 2017-18 using Attachment B.

Due to time constraint, PAC members agreed to table this item for the next meeting. On a motion by Cynthia Ripley, seconded by Pete Turner, the STA PAC agree to table this item for the next regular scheduled PAC meeting. (6 Ayes, 3 Absences, 0 Abstentions)

E. PAC Field Trip(s)

Kevin McNamara highlighted how helpful the past PAC field trips were. Mr. McNamara stated that the past field trips were informative and eye-opening. He really enjoyed both the walking trips as well as riding in the van to see all the different projects throughout Solano County. After some discussion about which date works for PAC members to go on field trips, majority of the members agree with having the field trip in either September or October. PAC members requested that STA staff identify a few dates and send it out to the PAC members.

10. INFORMATION – DISCUSSION

A. Top 10 Walks in Solano County

Ryan Dodged explained how successful the Solano County Top Ten Bike Rides maps was and STA is seeking to create a similar map for walking in Solano County. Mr. Dodge noted STA staff plans to propose ideas for the Top 10 Walks with the PAC in the Spring of 2018.

B. Joint BAC/PAC Meeting

Ryan Dodge specified that a joint BAC/PAC Meeting may be needed when actions are taken involving TDA Article 3 funding, although TDA funds only need to be approved by the BAC. Mr. Dodge commented he would like to involve both advisory committees to provide feedback and weigh in on their opinions. He will follow-up with PAC members on future dates for a joint BAC/PAC meeting after BAC's July committee meeting.

11. INFORMATIONAL ITEMS-NO DISCUSSION

A. 2016-17 PAC Meeting Attendance Matrix and Membership Status Esther Wan provided PAC Members with the PAC Attendance Matrix and Membership Status in the packet. No discussion.

12. COMMITTEE MEMBER COMMENTS AND FUTURE AGENDA TOPICS

Pete Turner announced that he may not be a PAC member anymore because he recently moved to Los Angeles. Mr. Turner will try to continue to attend PAC meetings until Mayor Patterson finds a replacement member to represent the City of Benicia for the PAC.

RE:	Pedestrian Priority Projects List – Update

Background:

The Solano Transportation Authority (STA) administers the Countywide Pedestrian Transportation Plan that identifies and plans for the implementation of countywide pedestrian transportation projects.

The Pedestrian Priority Project List is developed through a collaborative effort between the Pedestrian Advisory Committee (PAC), STA staff, and public works and planning staff from the member agencies. This creates a consistent foundation for the funding and delivery of projects in Solano County. An annual review of the Projects List is conducted to ensure that the list is up to date as projects are completed and priorities change at the local level.

Discussion:

The process for updating the Priority Project List involves STA staff beginning with the previously adopted list, eliminating completed projects, consulting with the various agencies on their current priorities, and finally identifying projects that are most ready for construction which are listed as either Tier 1 or Tier 2. All other projects fall to a master list of other envisioned projects.

In general, STA staff used the following as guidelines to determine Tier 1 and Tier 2 projects:

- 1. Tier 1 projects are those that have a <u>complete funding</u> plan, have <u>environmental approval</u>, and <u>can be implemented within three years</u>.
- 2. Tier 2 projects have been initiated by either a feasibility study, or have begun environmental review process, but have not reached Tier 1 status.

At the June 1, 2017 meeting, the PAC requested that STA staff assign tiers to each project in the proposed pedestrian priority projects list. The item was continued until the August 3, 2017 PAC meeting.

Recommendation:

Review, change, and approve the STA Pedestrian Priority Project List for FY 2017-18 using Attachment A.
